

**BUMBLE BEE RANCH ADVENTURES**  
**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

By signing this agreement, you are giving up certain rights, including the right to recover damages in case of injury, death or property damages. Read this agreement carefully before signing it. Your signature indicates your understanding of and agreement to its terms.

1. Acknowledge that a horse or mule or cattle may without warning or any apparent cause, buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person; and that saddles or bridles may loosen or break – all of which may cause the rider to fall, be jolted or gored, resulting in serious injury or death.
2. Acknowledge that horseback riding is a dangerous activity and involves **RISK** that may cause **SERIOUS INJURY AND IN SOME CASES DEATH**, because of the unpredictable nature and irrational behavior of horses, mules and cattle, regardless of their training and past performance.
3. Voluntarily assume the risk and danger of injury or death inherent in the use of the horse, mule, cattle, equipment such as firearms and vehicles including hummers, 4X4's, ATV's, helicopters or wagons or any combination thereof and gear provided to me by the stable, Bumble Bee Ranch Adventures (hereafter the "Stable" or "Releasees")
4. Acknowledge that there is substantial risk of injury or death in the use of any vehicle or aircraft, such as automobiles, helicopters, ATV's and Hummers. Such risks include, but are not limited to harm or damage caused by: negligence of the Releasees or others in the operation of the vehicle or aircraft, negligence in selecting a particular vehicle or aircraft in general or for a particular task, design flaws in the vehicle or aircraft, negligence in the selection of pilots, drivers or equipment, improper maintenance of equipment, failure to provide proper supplies, negligence in selection where to take the vehicle or aircraft, my own physical reactions to driving or flight, and actions of fellow passengers. I assume all such risks and waive any claim against Releasees for any damages, including death, caused by such risks, whether caused by Releasees negligence or not.
5. **RELEASE, DISCHARGE AND PROMISE NOT TO SUE** the Stable, Bumble Bee Ranch or Bumble Bee Adventures, doing business under its own names or any other name and/or any of its owners, officers, employees and/or agents (hereinafter the "Releasees"), for any loss, (including death) to my person or property.
6. Release the Releasees from any claim that such Releasees are or may be negligent in connection with my riding experience or ability including but not limited to training or selecting horses, mules, maintenance, care fit or adjustment of saddles, bridles, instruction on riding skills or leading and supervising rides.
7. **INDEMNIFY, AND SAVE AND HOLD HARMLESS** the Stable or any of its employees, guides or wranglers with regards to my or my minors' misuse of the horses or mule or any equipment or gear provided therewith. Misuse includes impairment caused by alcohol, drugs, or any other substance.
8. Agree to abide by and follow any instruction given or rules established by the stable or any of its guides, wranglers or drivers with regards to misuse of the horses, cattle or mule or firearms or vehicles, including hummers, 4X4's, ATV's, helicopters or wagons or any combination thereof, equipment or gear provided therewith.
9. The undersigned expressly agrees the foregoing release and waiver of liability, assumption of risk and indemnity agreement is governed by the State of Arizona and is intended to be as broad in and inclusive as is permitted by Arizona law, and that in the event any portion of this agreement is determined to be invalid, illegal or unenforceable, the validity, legality and enforceability of the balance of this agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
